Anotatsiya: Akademik tarjimada sun’iy intellektdan (AI) tobora ko‘payib borayotgani tarjima sifati haqida grammatik aniqlik va leksik ravonlikdan tashqari muhim savollarni tug‘dirdi. Xususan, kontekstga bog‘liq bo‘lgan ma’no, mualliflik pozitsiyasi va nutq konventsiyalarini saqlashni o‘z ichiga olgan tarjimaning pragmatik o‘lchovi qiyosiy inson va sun’iy intellekt tarjimasini tadqiqotlarida yetarlicha o‘rganilmaganligicha qolmoqda.
